

OPEN SCHOOLING & TRAINER APPRECIATION



Prep for you next show or just come out to play at our schooling event Saturday August 7th from 8:00AM to 3:30. Discounted rates shown below.

Gates will open at 7:30. Please turn onto the gravel road to the left just before the guard shack. If you arrive earlier than 7:30 please park on the shoulder of Portofino Drive until the gates open at 7:30AM. You will be checked in just after the gate and be assigned a pinnie and bridle number. Please have checks made out to Ali 2 Farms LLC. Forms will be available to download at www.portofinoequestrian.com and will also be available at registration that day. If paying by credit card, please email your registration form in advance so traffic is not held up to process your card

TRAINERS:

- Trainer fee free! Normally \$15 fee per rider, you pay no fee this day for any of your students! (If you are providing any instruction, you will still need to provide a Certificate of insurance to the barn)
- Bring 5 or more students and your personal ride/rides that day are complimentary.



STUDENTS:

- \$40 FOR XC per horse and rider(with or without trainer)
- \$20 for Stadium per horse and rider (See Stadium schedule below for appropriate level) Note: Stadium will be adjacent to the new Covered arena that will be under construction at the time of the schooling day.
- Ground person free day. We will waive the requirement of a ground person and we will have people monitoring the course as well as Thanksgiving Fire & Rescue being on premise.
